FROM THE EXECUTIVE DIRECTOR

Dear Friends,

This year with generous support from the community, HUD, and our partners, we made great strides in community care within Idaho by providing the key to overcoming barriers to access, opportunities, and security in housing and community! We educated over 300,000 Idahoans on best fair housing practices and their rights, had over 20,000 conversations about housing, and provided over 3,000 housing intakes from community members seeking rental assistance (connected Idahoans to over \$2 million in rental assistance), eviction prevention and fair housing education and justice (over 1,000 hours of legal services) in Idaho.

After touring the State to provide fair housing education and outreach, we learned that housing is the number one concern and healthcare follows closely behind. The two largest issues in every Idaho community. No county has enough affordable housing to meet the demand of its community members especially with the closure of assisted living/nursing homes and redevelopment and or mass evictions from affordable housing and mobile home parks. Families with children, people with disabilities, communities of color and seniors are being forced into institutional settings rather than less expensive, affordable, accessible housing opportunities. Families and community members in the Bunker Hill Superfund Site are still experiencing the health and economic consequences of heavy metal and lead contamination, farmworkers are still exposed to terrible heat, pesticide, smoke, fire, and harassment in their employment and housing, and barriers to affordable homeownership for communities of color and people with disabilities is at the same level as it was when the Fair Housing Act was passed. All of which, we are working with communities to address through fair housing education, outreach, mediation, negotiation, and enforcement actions. We have helped housing transactors make sure their housing is designed accessibly. We met with community members to address hate and harassment across Idaho and advocated for the passage of nondiscrimination laws on the basis of sexual orientation and gender identity across the state.

This year, we will celebrate the 55th Anniversary of the Fair Housing Act or Title VIII of the Civil Rights Act and kick off our soon to be 30th Anniversary of the Intermountain Fair Housing Council on October 19, 2023, (SAVE the Date) at Linen Building in Boise, Idaho, with "The Intermountain Fair"—bringing fair housing and community justice to all 44 counties! We will amplify our efforts to prevent eviction, investigate sales, lending, and appraisal bias, address Equal Access to housing for our LGBT+ community members, support efforts to increase tenants' protections and accessibility, educate about affordable homeownership opportunities, and address hate and harassment in housing and community. Fair housing is one of the most effective and inexpensive tools to keep people secure, housed and healthy. Here is to a healthy and just future for all Idahoans in ALL 44 Counties! 
2022-2023 SUCCESS STORIES



Last winter IFHC was able to educate a landlord enough to stop making poor rental history references about a family it had over charged for rent during their tenancy for and repairs upon their departure from the property, amounting to over \$9,000.00, which forced the family into a shelter for over 1 year. Because of our education they secured housing and are happily living in their home now. Collections are suspended.



This spring we were able to secure a refund of overpayment of rent and secured the housing and a voucher that was in jeopardy for a family whose housing provider had filed an eviction against them when the housing provider tried to force them to pay a rent increase months before it was enforceable. By intervening through educational letters and reporting the misconduct to the housing authority the family was reimbursed all of the over payment over \$2.000.00.



"Hi ... It's nice to hear from you and thank you for the update. I'm doing well and hope you are too. I've applied already. But wanted to thank you for everything you did to help me find and pay for housing. I'm a bit speechless thinking about everything you did. Just know that it was appreciated more than I can say."

I was able to help educate a client on their rights as tenants, and I was able to provide them with the proper information on how to handle their situation with their landlord. They contacted me back and was so grateful to be able to solve the situation with their landlord with the information I was able to provide and good conversation with their landlord and everything was settled. The client was just so grateful to have a company that is willing and able to help educate them and help point them in the right direction.



She said that because of the education letters and the meetings that it gave her a sense of confidence to not give in to the pressures of the Landlord, signing the new lease with the rent increase until the lease is a benefit for all parties.

Testimonials/Success Stories

LK, a single woman with an adult son and a two-year-old grandchild living with her. Her son was unemployed, and she major had had a surgery. Subsequently, she fell behind on rent payments. She was five past due when the months Property Manager served with a 3 Day Notice to Pay or Vacate. Investigator urgently The submitted an application for rent assistance on her behalf. Two weeks later. she approved for a total of five months of assistance. The client was able to stay in her home.

LN. single woman contacted Intermountain Fair Housing Council while she was pregnant and without housing. She had been prescribed bedrest due to her high-risk pregnancy and was unable to work. A case manager submitted an application for her, and she was approved for a 60 day stay at a hotel. Her hotel assistance paid through the middle was November, right around her baby's due date. She was very worried she would not have shelter after giving birth. The Case Manager worked with colleagues submit Reasonable to а Accommodation Request (RAR) extend her hotel allowance. The RAR affording the was approved, her opportunity to take her baby girl somewhere safe and secure when they were discharged from the hospital.


